## **General Description:**

Responsible for the operation and minor maintenance of a wide variety of gasoline or diesel-powered construction equipment, such as smooth or sheep foot rollers, brooms, mowers, front-end loaders, backhoes, water truck, dump trucks, transport truck and equipment trailers, and belly dump trailers. Operates equipment close to trees, rocks, ledges, dead and live gas and oil lines, and other obstructions. Participates in emergency operations involving snow, mud or other inclement weather conditions work, as directed. Responsible for performing minor repairs, preventive maintenance and servicing to equipment. Operates rollers or earth compactor; performs rough carpenter or laborer work in the installation or repair of fences, culverts, cattle guards, and road signs. Assists in concrete prep work, repairing paved roads with hot mix, resurfacing roads, chip sealing, weed mowing along roads and trimming trees along roadways. Performs miscellaneous duties in road yard and shop: cleaning, welding, helping mechanic, moving equipment and materials, unloading materials, culverts, base course, cattle guards, and cutting weeds. Employee must perform all duties with minimal supervision and perform other duties as assigned.
